The budget meeting of the North Sewickley Township Board of Supervisors was held on Tuesday, December 30, 2025, at 12:00 pm, at the Municipal Building, 893 Mercer Road, Beaver Falls. In attendance were Township Supervisors, Secretary/Treasurer, Lisa Crespo, and various members of the public.

The meeting was called to order by Chairman, Tom Roush.

### **PUBLIC SPEAK:**

Ashley Fisher – Presented a petition for public record, opposing the 2026 tax increase and discussed various reasons supporting the petition.

Maureen Pansera – 118 Bennet Dr – Discussion on why she feels she doesn't receive services from the Township and the ones she does receive are poor.

Jim Rombold – Douglass Road – Asked why the Edward Jones accounts don't show in the budget.

Tom Roush apologized to Maureen Pansera for the sewer/water issues, stated there is a new Chief of Police that will be able to work with her in the future with problems, advised there is a medication box in the Township building. Brian Seeger discussed the issues with adopting a road as a Township Road and why it is costly to do so.

Tom Roush addressed Ashley Fisher about the petition and informed her that he can appreciate her efforts but per the Second-Class Township code, the meeting must be adopted by December 31, 2025, and the residents presented the petition the day prior to the adoption. Discussed the high Riverside School District taxes. Tom informed the residents of the 24-hour services the Township provides to keep the Township running. He indicated average costs are going up 30 to 40% and we need to continue to do the best for our residents. Brian Seeger fully explained the differences in each section of the budget and why it was necessary for the increases. The full discussion was appreciated by the residents to help understand the tax increase.
